

ANNUAL TUITION FEE

Payment of the student's Annual Tuition Fee for the year is scheduled by the College. Various payment options are available but payments can only be processed by a nominated Credit Card (MasterCard or Visa) or Direct Debit deduction. Please note once nominated, the payment option chosen by the fee payer is ongoing, until the last student in the family exits the College. At the College Board meeting at the end of October, Board Directors discussed the Annual Tuition Fees for 2022 in light of anticipated funding and expenditure commitments for the coming years.

Some of the major considerations were:

- Residual impact of the coronavirus on families financial circumstances for 2022.
- Anticipate impact of the costs associated with the new Victorian Catholic Education Multi-Enterprise Agreement covering College staff employment salaries and conditions.
- Maintaining appropriate levels of funding to support the College's new STEAM building and sports court building project, which is due to be opened in 2024.

In light of these considerations, the St Columba's College Board has approved the Annual Tuition Fees for 2022 as listed which reflects a 2% increase from the 2021 fees.

3% EARLY PAYMENT DISCOUNT

A 3% discount will be offered to families if the student's 2022 Annual Tuition Fees are paid in full by 25 February 2022

10% HEALTH CARE CARD HOLDERS

A 10% discount will be offered to families on completion and successful application of the Government CSEF – Camping Sports and Excursions Form.

FAMILY DISCOUNT

A discount will apply where two or more students concurrently attend the College. The sibling discounts are 10% for the second student and 15% for all subsequent students.

PRIVATE TUITION FEES

Private tuition classes in Music, Speech and Dance are additional to the mainstream education program offered at the College. Payment for these classes is required by a scheduled Credit Card (MasterCard or Visa) or Direct Debit deduction; fees are deducted at the beginning of each term (Music)/semester (Dance). Please note this is an ongoing arrangement until the College has been notified in writing that lessons are no longer continuing. Should a student wish to discontinue any private tuition class the period of notice required in advance is a term for Music and a semester for Dance. Refunds are not available for any private tuition class. Family accounts in arrears may jeopardise a student being able to participate in any private tuition class.

LAPTOP PROGRAM
