



STANDARD COLLECTION NOTICE

1. St Columba's College collects personal information, including sensitive information about students and parents or legal guardians and family members before and during the course of a student's enrolment at the College. This may be in writing, through technology systems or in the course of conversations and may be direct from the individual or from another source. The primary purpose of collecting this information is to enable the College, Catholic Education Offices and the Catholic Education Commission of Victoria Ltd (CECV) to meet their legal, educational, administrative and duty of care responsibilities to the student to enable them to take part in all the activities of the College.
2. Laws governing or relating to the operation of a school require certain information to be collected and disclosed. These include relevant Education Acts and Public Health and Child Protection laws.
3. Health information about students (which includes information about any disability as defined by the Disability Discrimination Act 1992) is sensitive information within the terms of the Australian Privacy Principles (APPs) under the Privacy Act 1988. The College may require medical reports about students from time to time and may otherwise collect sensitive information about students and their families.
4. If any personal information requested by St Columba's is not provided, this may affect the College's ability to enrol a student, respond to enquiries, provide the student with educational and support services or allow a person to visit the College.
5. St Columba's may disclose personal and sensitive information for administrative, educational and support purposes (or may permit the information to be directly collected by third parties). This may include to:
 - School service providers such as the CECV, Catholic Education Offices, school governing bodies and other dioceses.
 - Third party service providers that provide online educational and assessment support services, documents and data management services, training and support services, hosting services, and software-as-a-service applications, such as Consent2Go, which may include email and instant messaging, SEQTA and Google's 'G Suite' including Gmail.
 - CECV and Catholic Education Offices to discharge its responsibilities under the Australian Education Regulation 2013 (Regulation) and the Australian Education Act 2013 (Cth) (AE Act) relating to students with a disability, including ongoing evaluation of funding adequacy for individual students.
 - CECV to support the training of selected staff in the use of the College's systems, such as SEQTA.
 - Another school to facilitate the transfer of a student.
 - Federal and State government departments and agencies acting on behalf of the government eg for audit purposes.
 - Health service providers, and people providing educational support and health services to the College, including specialist visiting teachers, sports coaches, volunteers, counsellors and providers of learning and assessment tools.
 - Assessment and educational authorities, including the Australian Curriculum, Assessment and Reporting Authority.
 - People providing administrative and financial services to the College.
- Anyone you authorise the College to disclose information to; and
- Anyone to whom the College is required or authorised to disclose the information to by law, including under child protection laws.
6. St Columba's is required by the Federal Australian Education Regulation (2013) and Australian Education Act 2013 (Cth) (AE Act) to collect and disclose certain information under the Nationally Consistent Collection of Data (NCCD) on students with a disability. The College provides the required information at an individual student level to the Catholic Education Offices and the CECV, as an approved authority. Approved authorities must comply with reporting, record keeping and data quality assurance obligations under the NCCD. Student information provided to the federal government for the purpose of the NCCD does not explicitly identify any student.
7. Personal information collected from students is regularly disclosed to their parents or legal guardians.
8. If you make an enrolment application to another School, personal information including health information provided during the application stage may be collected from, or shared with, the other school
9. St Columba's may use online or 'cloud' service providers to store personal information and to provide services to the College that involve the use of personal information, such as services relating to email, instant messaging and education and

assessment applications. Some limited personal information may also be provided to these service providers to enable them to authenticate users that access their services. This personal information may reside on a cloud service provider's servers which may be situated outside Australia. Further information about the College's use of an online or 'cloud' service providers is contained in the College's Privacy Policy.

10. St Columba's makes reasonable efforts to be satisfied about the protection of any personal information that may be collected, processed and stored outside Australia in connection with any cloud and third party services and will endeavour to ensure it will be located in countries with substantially similar protections as the APPs.

11. When the College uses Google's G-Suite including Gmail, some personal information (usually limited to name and email address) about students, parents or legal guardians may be transferred, stored and processed by Google in the United States, or in any other country through which Google provides these services or where it processes and stores information. This personal information will be stored and processed by Google in accordance with Google's terms and conditions stated in the G-Suite for Education Agreement which the College entered into with Google.

12. St Columba's Privacy Policy contains further information about its use of cloud and other third party service providers and any of their overseas locations.

13. Where personal, including sensitive information is held by a cloud computing service

provider on behalf of CECV for educational and administrative purposes, it may be stored on servers located within or outside Australia.

14. St Columba's personnel and the College's service providers, and the CECV and its service providers, may have the ability to access, monitor, use or disclose emails, communications (eg instant messaging), documents and associated administrative data for the purposes of administering the online network system and ensuring its proper use.

15. St Columba's Privacy Policy is accessible via the College website, newsletter, handbook, or from Reception. The policy sets out how parents, legal guardians or students may seek access to, and correction of their personal information which the College has collected and holds. However, access may be refused in certain circumstances such as where access would have an unreasonable impact on the privacy of others, or may result in a breach of the College's duty of care to the student, or where students have provided information in confidence. Any refusal will be notified in writing with reasons, if appropriate.

16. The College's Privacy Policy also sets out how parents, legal guardians, students and their families can make a complaint if they believe there has been a breach of the APPs and how the complaint will be handled.

17. St Columba's may engage in fundraising activities. Information received from you may be used make an appeal to you. We will not disclose your personal information to third parties for their own marketing purposes without your consent.

18. On occasions, information such as academic and sporting achievements, student activities and similar news is published in the College's newsletters and magazines, on our intranet and on our website. This may include photographs and videos of student activities such as sporting events, camps and excursions. St Columba's will obtain permissions from the student's parent or legal guardian (and from the student if appropriate) prior to publication to enable the College to include such photographs or videos in our promotional material or otherwise make this material available to the public such as on the internet. The College may obtain permissions annually, or as part of the enrolment process. Permissions obtained at enrolment may apply for the duration of the student's enrolment at St Columba's unless the College is notified otherwise. Parents and legal guardians will be reminded annually to notify the College if they wish to vary the permissions previously provided.

19. If you provide St Columba's with the personal information of others, such as other family members, doctors or emergency contacts, we encourage you to inform them you are disclosing that information to the College and why, that they can request access to and correction of that information if they wish and to also refer them to St Columba's Privacy Policy for further details about such requests and how the College otherwise handles personal information it collects and complaints it receives.
